- 1. If you have been provided with a quote for the installation of an air source heat pump by an alternative MCS-accredited provider, we will match the price you have been quoted by another provider subject to these Terms and Conditions.
- 2. The price you are quoted by us for an air source heat pump installation includes:
 - a. Heat loss assessment of your home
 - b. Survey of your home to assess potential air source heat pump options
 - c. Energy Performance Certificate (EPC) if applicable
 - d. Design & specification of a heat pump solution
 - e. Supply and Delivery of Products & Materials which includes:
 - i. Daikin Air Source Heat Pump up to 18kW
 - ii. Hot water cylinder, ancillary items, and controls
 - iii. Heating and electrical connections and associated pipework & cabling
 - f. Installation of air source heat pump and all other system components
 - g. Handover & Commissioning includes all associated paperwork, manuals, and guides
 - h. Microgeneration Certification Scheme (MCS) registration and all other administration including Boiler Upgrade Scheme (BUS) application
- 3. We will only match the price quoted by another provider on the basis that such provider is MCS accredited, a full quote has been provided by them, the quote provided is for a like-for-like installation and:

 - iii. Vaillant;
 - iv. Viessman; or
 - v. Nibe
- 4. We reserve the right to refuse a price match if:
 - a. we have assessed that the quote and/or design specification provided by another provider is not suitable for your home; and/or
 - b. we have assessed that the quote from another provider has not been given on a like-for-like basis.
